The monthly meetings are an opportunity for the shareholders to voice their opinions and concerns.

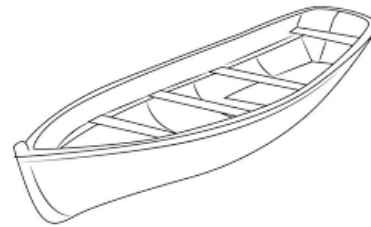
The board functions as you representatives, plan on attending a meeting to offer input.
