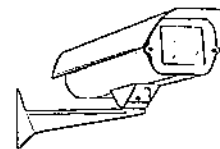
OFFICE HOURS

Household trash is normal everyday trash, kitchen, bathroom, etc. It does not include furniture, carpet, appliances, lumber, or cleaning out a house. For anything other than normal everyday trash there will be a charge depending on what it is. **HOWEVER, IF YOU ARE SAVING UP YOUR HOUSEHOLD TRASH FOR WEEKS AT A TIME AND HAVE A PICKUP BED OR TRAILER FULL, YOU WILL BE CHARGED A MINIMUM OF \$20 DOLLARS TO DUMP IT.**

Cedar Lake is still suffering from lack of water inflow from upstream, and WSC needs shareholders to join the fight for our water rights. As presented at the November meeting,

WSC retained an attorney, Timothy Sowecke with GableGotwals, to represent our interests before the Oklahoma Water Resources Board and perhaps District Court, if necessary. We have exhausted the \$24,000 in donations that have been made so far and must again ask shareholders to step up and give to the fund. Thanks to the stockholders who've donated in amounts ranging from \$25 to \$5000 so far. But to keep pressing for release of water that's rightfully ours, we need more donations
